POLITIQUE RELATIVE AUX COOKIES

1. INTRODUCTION

The ESOMUS Company with its software wishes to provide an exemplary service, so that its members are proud and fully satisfied. But he is essential to act within a legal framework. And, in this regard, we are legally required to provide you with certain information regarding cookies. This Cookie Policy therefore informs you about what cookies are, the types of cookies that are installed on your computer or other device when you visit one of our sites, and the purposes for using cookies.

2. WHAT ARE COOKIES?

A cookie is a small text file placed by an online service provider (such as ESOMUS and/or ESOMUS) on the computer or other device of visitors to its website. Cookies may collect information about visitors' habits when using the website, including: logging the activities of their computer or other device relating to said site, for example, when making purchases. The ESOMUS Company mainly uses cookies to operate the ESOMUS websites and to gather data to improve the services we offer you. We cannot identify you as an individual through cookies generated when you only visit one of our sites.

3. PERSONAL INFORMATION

4. TYPES OF COOKIES

When you visit one of our sites, four types of cookies may be placed on your computer or other device. These types of cookies are following: original (first-party) cookies, third-party cookies, session cookies and persistent cookies.

5. ORIGINAL (FIRST-PARTY) COOKIES

Original (first-party) cookies are cookies that we place directly on your computer or other device. They may include cookies such as session cookies and persistent cookies (explained below). We use original (first-party) cookies to track movements made from your computer or other device when you visit one of our sites, for example, for marketing and analytics purposes.

6. THIRD PARTY COOKIES

Third-party cookies are cookies that our business partners place on your computer or other device. Again, they may include cookies such as session cookies and persistent cookies (explained below). Our business partners use third-party cookies for targeting purposes, for example, so that advertisements that they believe best match your interests are chosen and delivered to your computer or other device, based on your past activities. computer or other device on the Internet.

7. SESSION COOKIES

The time between when you open your Internet browser and when you close it is called a browsing session. THE session cookies are cookies placed on your computer or other device during a browsing session, but which expire and are normally deleted at the end of a browsing session. We and our business partners use session cookies for a variety of reasons, including to track usage of our sites during a single browsing session, and to help you use our sites more efficiently. great efficiency. For example, session cookies are used to remind us that your computer or other device is connected to one of our sites.

8. PERSISTENT COOKIES

Persistent cookies are cookies placed on your computer or other device during a browsing session, but which remain on your computer or other device after the end of said browsing session. Persistent cookies allow our sites to recognize your computer or other device when it is used to re-access one of our sites, after the end of a browsing session and the start of a new browsing session, mainly to help you quickly reconnect to our site. We and our business partners also use persistent cookies for analytical purposes. Persistent cookies remain active for defined periods of time. Generally, persistent cookies placed on your computer or other device when you visit one of our sites remain active for a period of between one (1) day and five (10) years. More detailed information about cookies placed on your computer or other device when you visit one of our sites is provided below.

9. WHAT ARE OUR PURPOSE FOR USING COOKIES?

To help you better understand the use of cookies on our site, we have created the table below. This table lists the various types of cookies placed on your computer or other device when you visit our sites and the purposes for which cookies are used.

Cookie	Nom	Objectif d'utilisation
Session origin cookie	Search engine optimization keywords (Search Engine Optimization, SEO)	This cookie allows us to know which SEO keywords lead to attendance at ESOMUS or ESOMUS.
Session origin cookie	STCK_ID	This cookie allows us to map your visit to our site when you initially register for our services.
Session origin cookie	Operation Code	This cookie provides us with useful marketing statistics, for example, information about the time you spend on our site, and how often you log in and out. We use this data internally to improve the service we offer you.
Persistent original cookie	ID of the last account	This cookie allows us to link your computer or other device to your username in order to speed up your login process.
Persistent original cookie	UID	This cookie allows us to count the number of pages you clicked on when visiting our site.
Persistent original cookie	U2	This cookie collects information about your entire interaction with our website, for example, the pages you visit most often and your navigation on our website.

10. YOUR RIGHTS

We must obtain your consent to place cookies on your computer or other device. We obtain this agreement when you subscribe to our services, free of charge or against payment. If you wish to withdraw your consent, you can do so by canceling your subscription, in accordance with the instructions on your "My Account" page.

11. HOW CAN I DEACTIVATE COOKIES?

You can block the installation of cookies on your computer or other device by changing the settings of your browser, in accordance with the instructions received from your Internet browser provider or other device. However, please note that this blocking may greatly limit the satisfaction you can derive from your consultation of ESOMUS and you may even not be able to use our sites.
